PROPOSITION NO. 300 ORDINANCE NO. 802

An Ordinance Amending a Budget for the Town of Welsh, Louisiana, for the Fiscal Year 2019-2020.

WHEREFORE, the Mayor and Board of Aldermen for the Town of Welsh have promulgated and approved a budget for the fiscal year of 2019-2020, including all amendments this day passed, and wherefore all requirements of the Louisiana Statutes 39:130, et seq. including public notice and public hearing have been duly complied with, and wherefore the Mayor and Board of Aldermen desire to amend the 2019-2020 fiscal year budget.

BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Welsh, Louisiana, in regular session duly convened on Tuesday, November 10, 2020, that the budget for the Town of Welsh as promulgated and proposed for the fiscal year 2019-2020 be hereby amended by reduce \$90,000.00 in Jeff Davis Parish Landfill Revenues, reduce \$30,000.00 in Gen. Govt. R & M Building Expenditures, reduce \$30,000.00 in Police Communication Wages Expenditures, reduce \$16,500.00 in Rec. Baseball, Football, Soccer Salary & Wages Expenditures, reduce \$4,500.00 in Rec. Baseball, Football, Soccer Equipment Expenditures, reduce \$9,000.00 in Waste Collection Salary and Wages Expenditures, increase \$50,000.00 in Sales Tax Revenues, increase \$25,000.00 in Sales Tax Wages Expenditures, increase \$25,000.00 in Professional Services Miscellaneous in Expenditures, all in accordance with the Louisiana Revised Statutes 39:130, et seq., to be effective immediately upon signing by the Mayor.

THUS DONE AND PASSED at a regular meeting of the Mayor and Board of Aldermen for the Town of Welsh, Louisiana, held on the 1st day of December, 2020.

After public hearing was held on the above ordinance, the title having been read and the ordinance considered for adoption, the vote was taken and the following result was:
